Affiliation Process of AAs

Three stage process for Affiliation of an AA will be followed

Stage 1: Presentation & Application Submission by AA

Stage 2: Field Visit

Stage 3: Affiliation

Stage 1: Application- Prospective AA will submit the application in prescribed formats and give a presentation at IASC SSC office. IASC SSC reserves the right to select/reject the AA on merit. Also, AA has to register themselves on our portal with a fee of Rs. 10000 (online- Non-Refundable). However, in case of rejection same would be communicated to the applicant in writing.

Stage 2: Field Visit- IASC SSC team will visit the prospective AA, meet their key staff, and carry out verification of records and processes. AA who has successfully cleared Stage 2 would be invited for further process. The decision of this Committee would be final and binding to all AA.

Stage 3: Affiliation- All eligible AAs will be formally intimated by IASC SSC. The Affiliation will be valid for one year, after which the renewal of AA will be based on their performance or via floating RFP.
